DRIVING SAFETY COURSE OR DEFERRED DISPOSITION

IF YOU ENTER A PLEA OF EITHER GUILTY OR NOLO CONTENDERE, YOU MAY REQUEST IN WRITING A DRIVING SAFETY COURSE FOR PURPOSES OF TICKET DISMISSAL. YOU MUST MEET THE REQUIREMENTS UNDER THE SECTION OF THIS BROCHURE ENTITLED “**DRIVING SAFETY COURSE ELIGIBILITY AND REQUEST.**”
